3 **THE REGISTRAR:** Order; all rise. À l'ordre;  
4 veuillez vous lever.

5 This hearing of the Cornwall Public Inquiry  
6 is now in session. The Honourable Mr. Justice Normand  
7 Glaude, Commissioner, presiding.

8 Please be seated. Veuillez vous asseoir.

9 **THE COMMISSIONER:** Thank you. Good morning  
10 all.

11 Mr. Engelmann.

12 **THE COMMISSIONER:** Good morning, Mr.  
13 Commissioner.

14 **MR. ENGELMANN:** So Mr. Chand is back with us  
15 this morning to my immediate right ---

16 **THE COMMISSIONER:** Yes.

17 **MR. ENGELMANN:** --- counsel for Mr. Leroux.

18 **THE COMMISSIONER:** Yes.

19 **MR. ENGELMANN:** Sir, you recall last week  
20 you heard a motion dealing with a request that Mr. Leroux  
21 be excused from further cross-examination. We reserved  
22 until today. You had also asked for the provision of --  
23 you had suggested that counsel obtain a psychiatric report  
24 to provide you with some further medical evidence to assist  
25 you in making that decision.

1 I can advise, sir, that I did receive a call  
2 from Mr. Chand yesterday. He indicated to me that there  
3 would be no report this morning. He did indicate -- and  
4 I'll let him speak to it -- that an appointment has been  
5 made for Mr. Leroux to see someone in Ottawa, I believe  
6 next Monday. But I'll let him speak to that, sir.

7 **THE COMMISSIONER:** Thank you.

8 **MR. ENGELMANN:** So I believe he will be  
9 asking you for further time before you make your final  
10 decision on his request.

11 He has also filed an application for  
12 standing and funding so that Mr. Leroux can have standing  
13 as a party in this Inquiry, and perhaps I will turn it over  
14 to him to speak to both on those issues.

15 **THE COMMISSIONER:** Could I see the  
16 application please?

17 **MR. ENGELMANN:** Yes. Madam Clerk has  
18 copies.

19 **THE COMMISSIONER:** And that will be filed as  
20 what, now?

21 **MR. ENGELMANN:** Could that be the next  
22 exhibit sir?

23 **THE COMMISSIONER:** Well, do we not segregate  
24 applications for standing?

25 **MR. ENGELMANN:** You know, I asked -- I asked

1           our registry office that question and the applications for  
2           standing and funding that have been made subsequent have  
3           simply been given exhibit numbers in the normal course.

4                       This is certainly a motion, sir, or an  
5           application. We could give it a separate exhibit number if  
6           you feel it's appropriate.

7                       **THE COMMISSIONER:** Well, if we have done --  
8           no, it's okay.

9                       **MR. ENGELMANN:** We have done that in the  
10          past with the subsequent applications.

11                      **THE COMMISSIONER:** Six hundred and fourteen  
12          (614) is the application for standing on behalf of Mr.  
13          Leroux.

14          --- **EXHIBIT NO./PIÈCE NO. P-614:**

15                      Application of Standing and Funding re:  
16                      Ron Leroux

17                      **MR. ENGELMANN:** Sir, there is a Book of  
18          Authorities that I believe may have been filed this  
19          morning. I'm just seeing it now. I don't know if the  
20          clerk has copies of it.

21                      Do you have additional copies, sir?

22                      **THE COMMISSIONER:** I'm sorry?

23                      **MR. ENGELMANN:** Mr. Chand has just given me  
24          a Book of Authorities and apparently he has provided it to  
25          the parties. I don't know if he has made the requisite

1 numbers for the Commission pursuant to the rules.

2 I'll let him speak to that, sir.

3 **THE COMMISSIONER:** M'hm.

4 **MR. ENGELMANN:** I don't know if he has  
5 provided copies for you and the Registry Officer.

6 ---**SUBMISSIONS BY/REPRÉSENTATIONS PAR MR. PRADEEP CHAND:**

7 **MR. CHAND:** Yes, good morning, Mr.  
8 Commissioner.

9 I have -- with respect to the Book of  
10 Authorities I have provided a copy to all parties that are  
11 here today. I have provided one copy as well to Commission  
12 counsel. I have an extra copy here that I'm able to  
13 provide to you, sir, at this point.

14 **THE COMMISSIONER:** Thank you. Thank you.

15 **(SHORT PAUSE/COURTE PAUSE)**

16 Go ahead, sir.

17 **MR. CHAND:** Yes, Mr. Commissioner.

18 If I can just simply address the issue of  
19 the IME, if you'd like me to now address the issue of the  
20 IME report.

21 **THE COMMISSIONER:** Which is the independent  
22 medical examination?

23 **MR. CHAND:** That's correct, yes.

24 **THE COMMISSIONER:** Yes.

25 **MR. CHAND:** Now, in light of your remarks



1 last week we have now been able to canvass and investigate  
2 further to see if -- basically to determine the feasibility  
3 of Mr. Leroux going to have an independent medical  
4 examination.

5 And, as a result of our investigation we  
6 have been able to locate a doctor in the Ottawa area. And  
7 I have provided the parties with a copy of that particular  
8 doctor's resumé as well as confirmation indicating that Dr.  
9 Ken Welburn, who is a psychologist in the Ottawa area -- I  
10 must also say that he is a specialist in the area of PTSD,  
11 posttraumatic syndrome/stress syndrome as well as the issue  
12 of sexual assault. And as a result, he is prepared to see  
13 Mr. Leroux on Monday, August 27<sup>th</sup> at 11 a.m. That was the  
14 earliest appointment that I could arrange with this  
15 particular doctor.

16 I will also state that I canvassed other  
17 specialists both in the Ottawa area and my counterparts in  
18 London also; tried to determine whether there is an  
19 appropriate person in the London area that could see Mr.  
20 Leroux and it was difficult to arrange such an appointment  
21 within the timeframe. Some of the doctors that I did call  
22 happened to be away on vacation and this was one doctor  
23 that was willing to see him but the earliest possible date  
24 was Monday the 27<sup>th</sup>.

25 I'm able to provide you at this point with a

1 copy of Dr. Ken Welburn's CV as well as a letter confirming  
2 Mr. Leroux's appointment on Monday, August the 27<sup>th</sup>.

3 **THE COMMISSIONER:** Exhibits, please?

4 Go ahead.

5 **MR. CHAND:** Yes. In light of those  
6 submissions, Mr. Commissioner, we would be asking for an  
7 adjournment in order to give Dr. Welburn the opportunity to  
8 assess Mr. Leroux and provide a report by the end of next  
9 week. I've received assurances from Dr. Welburn that he  
10 will do his best to get it done within one or two days, but  
11 at the most it would be completed by the end of next week.

12 **THE COMMISSIONER:** M'hm.

13 **MR. CHAND:** Those are my remarks on that  
14 issue, Mr. Commissioner.

15 --- **RULING ON ADJOURNMENT BY THE COMMISSIONER/DÉCISION**  
16 **CONCERNANT L'AJOURNEMENT PAR LE COMMISSAIRE**

17 **THE COMMISSIONER:** All right.

18 Anybody else wish to comment with respect to  
19 the request for an adjournment?

20 Thank you. I will very reluctantly grant  
21 you that adjournment. I know that you are new to this  
22 Inquiry and we measure time in hours and days as much as  
23 possible. And while I am disappointed, I suppose, that we  
24 cannot deal with this matter today, especially since other  
25 positions have been suggested that were quite capable and

1 willing of having the matter dealt with, with an  
2 appointment setup and a report done as quickly as possible  
3 and we'll see what the report says.

4 But I am telling you now, though, that the  
5 report needs to be prepared and done by next week.

6 So Mr. Engelmann, dates when we can?

7 **MR. ENGELMANN:** Sir, we have obviously  
8 witnesses scheduled for the dates when this will be coming  
9 back. We are here next Thursday, Wednesday -- well, we are  
10 here all of next week.

11 **THE COMMISSIONER:** M'hm.

12 **MR. ENGELMANN:** We could -- we could perhaps  
13 deal with this matter sometime on the 30<sup>th</sup>.

14 **THE COMMISSIONER:** The 30<sup>th</sup> is?

15 **MR. ENGELMANN:** Thursday.

16 **THE COMMISSIONER:** Yes.

17 **MR. ENGELMANN:** We anticipate we will be in  
18 the evidence of a church context expert at that time but we  
19 could have the report spoken to or, sir, the next available  
20 date we have is in the afternoon of September 10<sup>th</sup>.

21 **THE COMMISSIONER:** M'hm.

22 **MR. ENGELMANN:** And depending on your  
23 decision we have witnesses that we have set up for that  
24 time, or if Mr. Leroux was to continue with his testimony  
25 he could do so that afternoon.

1                   There is also the possibility, again I'm  
2                   just thinking about when this report is going to be done,  
3                   if it is not done until Thursday or Friday of next week --  
4                   if it's done on Thursday, it could be spoken to on  
5                   Thursday. If it is not, if it's done on Friday, we are  
6                   inevitably looking at September 10<sup>th</sup>, which is a Monday or  
7                   coming back on a non-scheduled hearing date to deal with  
8                   this matter.

9                   If we were to deal with the matter and hope  
10                  to continue either with Mr. Leroux' evidence or with  
11                  someone else's, perhaps it is more appropriate the  
12                  afternoon of September 10<sup>th</sup>.

13                  I'm in your hands, sir.

14                  **THE COMMISSIONER:** No, I want to deal with  
15                  this matter as quickly as possible.

16                  **MR. ENGELMANN:** All right.

17                  **THE COMMISSIONER:** So I would say next  
18                  Thursday -- next Thursday at 2:00 p.m.

19                  **MR. ENGELMANN:** All right.

20                  **THE COMMISSIONER:** Mr. Manson.

21                  ---**SUBMISSIONS BY/REPRÉSENTATIONS PAR MR. ALLAN MANSON:**

22                  **MR. MANSON:** I would suggest a condition on  
23                  the adjournment.

24                  **THE COMMISSIONER:** What's that?

25                  **MR. MANSON:** In that it relates to the

1 distribution of the report.

2 THE COMMISSIONER: M'hm.

3 MR. MANSON: If we are going to speak to  
4 this matter next Thursday at 10:00 ---

5 THE COMMISSIONER: At 2:00.

6 MR. MANSON: At 2:00 rather, is there any  
7 reason why we can't get the report by next Monday or  
8 Tuesday, and that it be distributed?

9 THE COMMISSIONER: Well, he is seeing the  
10 witness on Monday.

11 MR. MANSON: On Monday, yes.

12 THE COMMISSIONER: So if he sees him on  
13 Monday, he gets Tuesday to write up the report. So  
14 Wednesday at 4:00?

15 MR. MANSON: Wednesday at 4:00 is better  
16 than Thursday at 2:00. Thank you.

17 THE COMMISSIONER: All right. Report to be  
18 prepared and distributed by Wednesday at five o'clock.

19 MR. CHAND: Mr. Commissioner, as you well  
20 know, I also filed an Application for Standing and Funding.  
21 Would you rather me address that issue at that time?

22 THE COMMISSIONER: Sure.

23 MR. CHAND: Okay. Thank you.

24 THE COMMISSIONER: Okay, great. Thank you.

25 MR. ENGELMANN: So sir, Wednesday at 5:00

1 for distribution of the report to the Commission and all  
2 parties; Thursday at 2:00 p.m. to hear the continuation of  
3 this motion on whether or not he should be excused and also  
4 the Standing and Funding Motion at that time.

5 **THE COMMISSIONER:** Yes. All right. Thank  
6 you.

7 **MR. ENGELMANN:** If we could take a short  
8 break then.

9 **THE COMMISSIONER:** Yes.

10 **MR. ENGELMANN:** So that I can bring my  
11 materials in and go back with the evidence of the current  
12 witness.

13 **THE COMMISSIONER:** Thank you.

14 **THE REGISTRAR:** Order. All rise. À  
15 l'ordre. Veuillez vous lever.

16 The hearing will resume at 10:30.
