AFFIDAVIT

I, Derrick Fulton, of the City of Toronto, in the Province of Ontario, MAKE OATH AND
SAY:

1. I am a lawyer at Steinberg Morton Hope & Israel, lawyers for the Respondents, and as such I have knowledge of the information to which I hereinafter depose. If the matters in issue are within my knowledge they are true. If such matters are based on information from others, I verily believe that information to be true.

2. The Respondents were served with four Summonses to Produce Documents by the Elliot Lake Commission of Inquiry (the "Commission"), two dated September 6, 2012, September 13, 2012 and December 6, 2012. As required by the Summonses, the Respondents have taken a number of steps to comply with the document production requirements and have provided all documents within their possession and control to the Commission.

3. On or about March 8, 2013, the Respondents delivered approximately 85,000 emails to the Commission's data management firm in response to the summonses.

4. I reached an agreement with Commission Counsel whereby the Commission would retain the services of an external law firm to review the 85,000 emails produced by the Respondents for relevance and privilege.

5. On or about March 27, 2013, the external law firm provided me with a CD containing 2,622 potentially privileged documents for review.

6. The review of the 2,622 documents was arduous and extremely time consuming. The review was conducted as quickly as possible, with regard paid to the strict timelines set by Commission Counsel.

7. On or about April 26, 2013, I provided Commission Counsel with a chart assessing the 2,622 documents and identifying the documents as privileged, irrelevant or appropriate for release into the public record. Of the 2,622, I identified 1,950 documents over which the Respondents claimed privilege.

8. On or about June 11, 2013, I was served with the Application Record of the Applicant. Therein the Applicant identified 543 documents, from the 1,950 privileged documents referred to above in paragraph 7, for which it seeks a declaration that these documents are not privileged on the basis that the evidence provided does not establish that the document in question is a communication to or from the lawyer for the purpose of obtaining or providing legal advice.

9. I have reviewed all 543 documents and have compiled a chart setting out the basis on which privilege is being claimed. I have also identified those documents which I have determined are not privileged. The said chart is attached hereto and marked as Exhibit "A" to this my affidavit.

10. The details of my review, as provided in the chart, are as follows:

- (a) 30 documents have been identified as not privileged;
- (b) Additional evidence is provided for all documents which Commission Counsel had identified as lacking an evidentiary basis on which to conclude that the document is privileged;
- (c) In respect of approximately 125 documents, the Respondents are claiming settlement and/or litigation privilege. The Respondents have commenced an action against Zurich Insurance Company Ltd.; the Statement of Claim was issued on June 17, 2013. These communications relate to settlement negotiations between the Respondents and the insurance company or otherwise were created in contemplation of the said litigation.


11. On or about June 11, 2013, the Commission Counsel provided the Respondents with a list of 15 documents, which were previously identified as appropriate for release on April 26, 2013, and advised that these documents may be privileged. Upon further review of these documents I have identified four documents, namely documents numbered NAZ_E000002744, NAZ_E000005744, NAZ_E000008132, and NAZ_E000017482, over which the Respondents claim solicitor-client and/or litigation privilege. The previous identification of these documents as

appropriate for release was made in error and the Respondents do not waive privilege over these documents.

12. The Respondents are prepared to provide the Honourable Justice Goudge with the required documents to assist in their determination of privilege.

13. I make this affidavit in support of the Responding Application Record of the Respondents, and for no other or improper purpose.


