NOTICE OF MOTION FOR ADDITIONAL FUNDING (Returnable April 9, 2013)

The Corporation of the City of Elliot Lake ("City") is making a motion to the Elliot Lake Commission of Inquiry ("Inquiry"), as soon as the motion can be heard at the White Mountain Building, 99 Spine Road Elliot Lake, Ontario, P5A 3S9.

PROPOSED METHOD OF HEARING:

The motion is to be heard in writing.

THE MOTION IS FOR:

- 1) A request that the Commissioner recommend that the Attorney General approve funding for an additional 10 hours/day for the Wishart Law Firm LLP, counsel for the City, which funding would be available to either:
 - i) Mr. Matthew Shoemaker, to be funded as a Student-at-Law until June 18, 2013 and then to be funded as a junior lawyer when he is called to the bar on June 18, 2013; or
 - ii) Ms. Alexandria Tomasovic Little (called to the bar 2005) to be funded as a junior lawyer commencing immediately.
- 2) The requested additional funding would bring the maximum number of hours/day of funding for the City to 30 hours/day rather than the current maximum of 20 hours/day.
- 3) Such further and other relief as this Honourable Commission may deem just.

THE GROUNDS for the motion are:

CITY STANDING AND FUNDING

- Pursuant to the Commissioner's Ruling on Standing and Funding dated November 8, 2012, the Commissioner made the following Standing and Funding rulings:
- 2) Standing = At Page 6, the Commissioner provides:

- (1) The Corporation of the City of Elliot Lake: The City of Elliot Lake has a clear and important interest in the issues raised by the Order in Council and meets the criteria for full standing. Full standing in all aspects of the work of the Commission is granted.
- 3) Funding = At Page 11, the Commissioner provides:
 - (1) I recommend to the Attorney General that funding for one senior counsel and one junior counsel be provided in accordance with the Guidelines for Reimbursement of Legal Fees and Disbursements. Counsel for the City has advised that different lawyers from Wishart Law Firm LLP will replace counsel on occasion and that the City is not seeking funding for more than one senior counsel to be present at the inquiry at any one point.
 - (2) It is further noted at Page 19 that the nature of the funding request approved was more particularly, "one senior counsel, two junior counsel, one articling student, one law clerk (only one counsel at any one point), accommodation"

CURRENT LAWYERS AND LAW STUDENT

- The City's law firm at the Inquiry is the Wishart Law Firm LLP, namely, Mr. Paul Cassan as the senior lawyer, Mr. Steven Shoemaker as the junior lawyer and Mr. Matthew Shoemaker being the Student-at-Law on the file;
- 5) The Wishart Law Firm LLP, on behalf of the City, is currently approved for a maximum of 20 hours/day between Mr. Cassan, Mr. Steven Shoemaker and Mr. Matthew Shoemaker.
- 6) As Mr. Cassan has relocated to Elliot Lake for the purposes of the Inquiry he attends the hearing for approximately eight (8) hours per day and then continues his preparation in the evening for the next witness.
- 7) As such, Mr. Cassan generally works 14-16 hours/day in spite of only being funded for 10 hours/day. This essentially leaves 10 hours for Mr. Steven Shoemaker and Mr. Matthew Shoemaker to support Mr. Cassan.

DOCUMENT DATABASE

8) The Inquiry has generated more than 50,000 pages of relevant documents currently contained in a document database known as Relativity.

9) Further, the pre-Inquiry due diligence required review and examination of thousands of other pages of documentation that were ultimately either deemed by counsel for the City to be irrelevant to the Inquiry or protected by privilege.

CURRENT AND FORMER CITY EMPLOYEES

- 10) All current employees of the City who are likely to be questioned will be represented by the Wishart Law Firm LLP and this includes pre-testimony interviews to generate a will-say statement and a pre-testimony brief of documents to review and examine, many briefs being anywhere from 50-150 tabs.
- 11) Almost all the former employees of the City have requested representation from the Wishart Law Firm LLP and each of these former employees has been or will be questioned for pre-testimony interviews;
- 12) For the first month of the Inquiry, there have been many days where interviews of former and current City employees occurred on the same day as the Inquiry hearing dates, including more so recently, with Mr. Cassan, Mr. Steven Shoemaker and Mr. Matthew Shoemaker being required to work simultaneously on the Elliot Lake file on March 19, 21, 22, 25, and 26.
- 13) The numbers of days where three lawyers will be required to be either in Elliot Lake or working on preparation for witnesses and interviewees has increased every week since the commencement of the Inquiry on March 4, 2013.
- The requirement to have three lawyers on the file will continue to increase moving forward as the schedule to date for Phase I up until May 2 includes eight (8) City witnesses, with initial interviews needed by Commission Counsel for four (4) of those eight (8) witnesses before May 2, 2013 and testimony from four (4) City witnesses before May 2, 2013.
- 15) During this time, cross-examinations of the non-City witnesses who are scheduled to testify must be prepared in the evening by Mr. Cassan with the assistance of Mr. Steven Shoemaker and Mr. Matthew Shoemaker.
- 16) As of March 25, 2013, the list of potential Phase II witnesses provided by Commission Counsel includes another five (5) City witnesses at this time, all of whom will have to be interviewed in relation to Phase II issues. There are likely to be other City witnesses added to either Phase I or II as well.

ALL WITNESSES INTEGRAL TO CITY

17) Of the non-City witnesses, there are essentially no witnesses that are irrelevant to the City's position as many, if not all, of these witnesses have had, or perhaps

ought to have had, dealings with the City throughout the last 33 years since the mail was originally constructed. Then, much like Commission Counsel, the City must prepare and cross-examine essentially every witness that takes the stand and this requires preparation and examination of many documents on a daily basis to suitably represent the City's interests.

18) Furthermore, on days when a City witness is testifying, two lawyers from the Wishart Law Firm LLP attend the hearing to ensure comprehensive questioning and reply of the City related witness, thereby generally leaving only Mr. Matthew Shoemaker to prepare materials for the upcoming witnesses.

CHANGE IN SCHEDULE

- 19) On March 25, 2013, as a result delays from the initial schedule, the hours of the inquiry were extended from 9am to 5pm instead of 930am to 430pm, thereby providing less time for the lawyer attending the hearing to prepare in the morning before the Inquiry and in the evening after the Inquiry.
- Regardless as to whether a City or non-City representative is on the stand, because of the number of documents, especially which relate to the City's interest, I know that either one or both of myself and Mr. Matthew Shoemaker are either attending interviews of City witnesses, summarizing will-say statements, examining documents contained within witness brief, examining non-brief documents contained in the relativity database, helping prepare the initial draft of cross-examination questions, preparing for cross-examinations of some witnesses, or otherwise reporting to Mr. Cassan and as to upcoming witnesses.
- On many days when Mr. Matthew Shoemaker has performed the above noted tasks outlined in paragraph 20 above, he has done so at no charge to the Inquiry, as the interests of the City required this additional support even on days where Mr. Cassan and Mr. Shoemaker have exhausted their maximum available funding. Nonetheless, Mr. Matthew Shoemaker's efforts were required even if unfunded because the primary concern is the City's comprehensive representation.
- 22) No alternative sources of funding or insurance are available for this process;
- 23) Such further and other grounds as this Honourable Court may permit.

THE FOLLOWING DOCUMENTARY EVIDENCE will be used at the hearing of the motion:

1) The Affidavit of Steven G. Shoemaker sworn April 9, 2013 together with exhibits referred to therein;

2) Such further and other material as counsel may advise and this Honourable Court may permit.

AFFIDAVIT OF STEVEN G. SHOEMAKER (Sworn April 9, 2013)

- I, STEVEN G. SHOEMAKER, of the City of Sault Ste. Marie, in the District of Algoma, make oath and say as follows:
- 1) I am a solicitor employed with the Wishart Law Firm LLP and as such have personal knowledge of the matters hereinafter deposed to except where stated to be based on information and belief.

ORIGINAL REQUEST FOR STANDING AND FUNDING

2) In its original request, the City of Elliot Lake ("City") through its counsel, the Wishart Law Firm LLP, requested full standing and, after resolving an issue with respect to counsel representing the City, applied for and was granted a recommendation for funding for the entire Inquiry.

RULING ON STANDING AND FUNDING

- 3) Pursuant to the Ruling on Standing and Funding dated November 8, 2012 ("Ruling"), the City obtained standing to participate in all areas of Inquiry and funding for one senior counsel, Mr. Cassan and one junior counsel, Mr. Steven Shoemaker or one articling student, Mr. Matthew Shoemaker with no more than one counsel to be present at the Inquiry at any one point, which is generally Mr. Cassan.
- 4) The Wishart Law Firm LLP, on behalf of the City, is currently approved, pursuant to the Ruling for a maximum of twenty (20) hours/day allocated between Mr. Cassan, Mr. Steven Shoemaker and/or Mr. Matthew Shoemaker.
- 5) Mr. Cassan has relocated to Elliot Lake for the purposes of the Inquiry and I am advised and do further know, that he generally works 14-16 hours/day in spite of only being funded for ten (10) hours/day.

6) In addition to Mr. Cassan's 10 hours/day, Mr. Matthew Shoemaker and I work either individually or collectively a further ten (10) hours/day to support the City and Mr. Cassan's representation of the City at the Inquiry.

ADDITIONAL HOURS/RATE BEING SOUGHT

- 7) Our firm, on behalf of the City, is requesting that the Attorney General approve funding for ten (10) hours/day for Mr. Matthew Shoemaker, or Alexandria Tomasovic Little, thereby entitling the Wishart Law Firm LLP a total of 30 hours/day, rather than the current maximum of 20 hours/day.
- 8) Furthermore, the above request is for Matthew Shoemaker to be paid at a Student-at-Law rate until June 18, 2013 and then at a junior lawyer rate once he is called to the bar on June 18, 2013 or alternatively, at times, for Ms. Alexandria Tomasovic Little to be paid at a junior lawyer's rate when Mr. Matthew Shoemaker is unavailable.

DOCUMENT DATABASE

- 9) I know and do verily believe that the Inquiry has generated more than 50,000 documents, some of which are composed of more than 1000 pages of relevant documents currently contained in a document database known as Relativity, of which both Mr. Matthew Shoemaker and I use on a daily basis to identify, query and investigate documents relevant to the upcoming witnesses or interviewees.
- 10) I know that during the pre-Inquiry due diligence, thousands of other pages of documents were reviewed and examined and were ultimately either deemed by counsel for the City to be irrelevant to the Inquiry or protected by privilege.
- 11) All current employees of the City who are likely to be questioned will likely be represented by the Wishart Law Firm LLP and this includes pre-testimony interview to generate a will-say statement and a pre-testimony brief of documents to review and examine, many briefs being from 50-150 tabs. For example, see the document brief indices for Roger Pigeau, Fred Bauthus, and Troy Speck, which are attached hereto as **Exhibits A, B, and C** respectively.
- 12) To be clear, the process that is occurring, which was not anticipated in the initial application, is that simultaneous with the hearing being conducted, other members of Commission Counsel are interviewing upcoming witnesses, being both past and current employees of the City. The City has the largest number of witnesses involved in the Inquiry by a substantial margin.
- 13) Presently there are approximately 15 witnesses associated with the City who have testified or are expected to testify at the Inquiry with some of these witnesses interviewing and testifying on multiple occasions as their employment with the City

spanned various time periods at the City or they are relevant to both Part I and Part II of the Inquiry

REPRESENTATION OF CURRENT AND FORMER CITY EMPLOYEES

- 14) Almost all the former employees of the City have requested representation from the Wishart Law Firm LLP and each of these former employees has been or will be questioned as part of pre-testimony interviews.
- 15) For the first month of the Inquiry, there have been many days where interviews of former and current City employees occurred on the same day as the Inquiry hearing dates, including more so recently, with Mr. Cassan, Mr. Steven Shoemaker and Mr. Matthew Shoemaker being required to work simultaneously for ten (10) hours per day on the Elliot Lake file on March 19, 21, 22, 25, and 26.
- 16) For example, I know and I am further advised by Mr. Paul Cassan and Mr. Matthew Shoemaker of the following:
 - a) On March 19th, Mr. Matthew Shoemaker was required to attend in Elliot Lake for the continuance of Larry Burling's pre-testimony interview while Mr. Steven Shoemaker prepared for the cross-examination of upcoming witnesses and the examination in chief of Roger Pigeau scheduled for March 22 and Mr. Paul Cassan attended the Inquiry hearing;
- b) On March 21st, Mr. Steven Shoemaker and Mr. Matthew Shoemaker had to drive to Elliot Lake in the evening to ensure Mr. Steven Shoemaker's attendance at the hearing to examine and represent the former Chief Building Officer of the City, Mr. Roger Pigeau on March 22, 2013 and for Mr. Matthew Shoemaker to attend Mr. Fred Bauthus' continuing pretestimony interview in preparation for his actual testimony on March 26, 2013. On the 21st Mr. Cassan prepared the examination in chief of Mr. Bauthus for his testimony on March 26; 2013 and attended the hearing to ensure a comprehensive representation of this integral City witness.
- On March 22nd, the examination of Mr. Roger Pigeau extended until Monday, March 25 thereby moving the examination of Mr. Bauthus to March 26. As such, I was required to be in Elliot Lake for the continued testimony of Mr. Pigeau on March 25, 2013 while Mr. Cassan continued to prepare for the testimony of Mr. Bauthus and of Mr. Leistner who was scheduled for March 27;
- d) Both Mr. Pigeau and Mr. Bauthus are two critically important witnesses to the interests of the City of Elliot Lake as Mr. Pigeau was the Chief Building Officer from 1980 to 1999 and Mr. Bauthus was the Chief Administrative Officer from 1990 to 2000.

- 17) The numbers of days where three (3) lawyers will be required to either be in Elliot Lake in person or working on preparation for witnesses and interviewees at the Wishart Law Firm LLP offices in Sault Ste. Marie, has increased every week since the commencement of the Inquiry on March 4, 2013.
- 18) The requirement to have three (3) lawyers on the file will continue to increase moving forward as the schedule to date for Phase I up until May 2, 2013 includes eight (8) City witnesses with initial interviews by Commission Counsel for four (4) of those eight (8) witnesses and testimony from four (4) more City witnesses before May 2, 2013. The most recent list of currently scheduled witnesses is attached hereto as Exhibit D [highlights added].
- For example, I know and I am further advised by Mr. Cassan and Mr. Matthew Shoemaker that,
 - a) On April 5, 2013, Mr. Cassan attended the hearing while Mr. Matthew Shoemaker attended in Elliot Lake for a pre-testimony interview with Mr. Clouthier, a current building inspector with the City. Mr. Steven Shoemaker worked on the Elliot Lake file in Sault Ste, Marie.
 - b) On April 9, Mr. Cassan will attend the hearing and Mr. Matthew Shoemaker will again be in Elliot Lake for the interview of Mr. Bauthus as it relates to Mr. Bauthus' second period of employment with the City. Mr. Shoemaker will be working from Sault Ste. Marie on preparing for the upcoming week of witnesses.
 - c) On April 10, Mr. Cassan will attend the hearing and either one of either myself or Matthew Shoemaker will attend the interview with Mr. Paul Officer in Elliot Lake.
 - d) Also on April 10, Ms. Trudy Rheaume will be questioned as to the Emergency Management Plan of the City and either Mr. Matthew Shoemaker or I will also attend this interview in Elliot Lake.
 - e) Thereafter, between April 23 and May 2, all of the witnesses testifying during the hearings days for that time period are current or former City employees and are represented by the Wishart Law Firm LLP, and this includes many key City employees after the year 2000.
- 20)Beyond May 2, 2013, it is expected that Phase I will include at least another four (4) City witnesses and these interviews must also be conducted by Commission Counsel. The most recent schedule for after May 2, 2013 is attached hereto as **Exhibit E** [highlights added].
- 21) It is anticipated that both before and after May 2, 2013, cross-examinations of the non-City witnesses who are scheduled to testify must be prepared in the evening by

- Mr. Cassan with the assistance of Mr. Steven Shoemaker and Mr. Matthew Shoemaker. The non-City witnesses are also listed within Exhibits D and E.
- 22) As part of Phase II, the list of potential witnesses provided by Commission Counsel as of March 25, 2013, includes another five (5) City witnesses at this time, all of whom shall have to have the pre-testimony interviews in relation to the Phase II issues. The Phase II list of potential witnesses is attached hereto as Exhibit F. [highlights added]. It is anticipated that other City witnesses will be added to either Phase I or Phase II.

ALL WITNESSES INTEGRAL TO CITY

- 23) Of the non-City witnesses, there are essentially no witnesses that are irrelevant to the City's position as many, if not all, of these witnesses have had or perhaps ought to have had dealings with the City throughout the last 33 years since the mall was originally constructed.
- 24) Much like Commission Counsel, the City must prepare and cross-examine every witness that takes the stand and this requires preparation and examination of a multitude of document briefs or non brief documents through Relativity. These investigations and examinations take place on a daily basis by Mr. Steven Shoemaker and Mr. Matthew Shoemaker to ensure suitable representation of the City's interests.
- 25) Furthermore, on days when a City witness testifies, two lawyers from the Wishart Law Firm LLP have attended at the Inquiry to ensure comprehensive adducing of new evidence and examination in chief of the City witness. The attendance of two lawyers at the hearing leaves the remaining approved lawyer, generally Mr. Matthew Shoemaker, to prepare materials for the upcoming witnesses.

CHANGE IN SCHEDULE

- 26) On March 25, 2013, as a result delays from the initial schedule, the hours of the Inquiry were extended from 9am to 5pm instead of 930am to 430pm, thereby leaving less time for the lawyer attending the hearing to prepare in the morning before the Inquiry and in the evening after the Inquiry.
- 27)In other words, the original schedule involved a hearing day of 7 hours, thereby providing 3 hours for further preparation by Mr. Cassan. The new schedule involves a hearing day of 8 hours leaving only 2 hours for preparation. Counsel from the Wishart Law Firm LLP respectfully submits that these time limits are inadequate to properly represent the City and Mr. Cassan has been spending in excess of 12 to 14 hours per day.

- 28) Regardless of whether a City or non-City employee is on the stand, because of the number of documents, especially which relate to the City's interest, I know that either one or both of myself and Mr. Matthew Shoemaker are either attending interviews of City witnesses, summarizing will-say statements, examining documents contained within witness brief, examining non-brief documents contained in the relativity database, helping prepare the initial draft of cross-examination questions, preparing for cross-examinations of some witnesses, or otherwise reporting to Mr. Cassan and as to upcoming City or non-City witnesses.
- 29) On many days when Mr. Matthew Shoemaker has performed the above noted tasks, he has had to do so at no charge to the Inquiry, as the interests of the City required the additional support even on days where Mr. Cassan and Mr. Shoemaker were also preparing to represent the City at the Inquiry. The primary concern has been and continues to be the City's representation. However, it is on this basis that we seek the requests for additional funding.
- 30) No alternative sources of funding or insurance are available for this process in accordance with the funding guidelines and this is noted within the documents contained in the Motion Record of the Corporation of the City of Elliot Lake dated November 1, 2012.
- 31) I make this affidavit for no improper purpose, but in support of:
 - a) A request that the Commissioner recommend that the Attorney General approve funding for an additional 10 hours/day for the Wishart Law Firm LLP, counsel for the City, which funding would be available to either:
 - i) Mr. Matthew Shoemaker, to be funded as a Student-at-Law until June 18, 2013 and then to be funded as a junior lawyer when he is called to the bar on June 18, 2013; or
 - ii) Ms. Alexandria Tomasovic Little (called to the bar 2005) to be funded as a junior lawyer commencing immediately.
- 32) The requested additional funding would bring the maximum number of hours/day of funding for the City to thirty (30) hours/day rather than the current maximum of twenty (20) hours/day.
