NOTICE OF APPLICATION FOR STANDING AND FUNDING

INTRODUCTORY REMARKS

Mr. Carson Chisholm has already made an application for standing and funding through his lawyer Frank Horn.

The Coalition for Action have been involved for about 15 years in supporting the position of Carson Chisholm, his brother-in-law and sister, Perry and Helen Dunlop. This core of individuals in the Coalition have consistently been advocating the same position as Carson Chisholm and Perry and Helen Dunlop.

The group who are now called The Coalition for Action were at different times called other names. At one point they were called The Citizens for Bill 103, and they were also the people who gathered names for the petition in 1993-94, advocating support for Perry Dunlop's action in going to The Children's Aid Society with the complaints of child sexual abuse.

The group of concerned citizens who make up The Coalition For Action were the people who petitioned to have this Public Inquiry. There is a great difference between the Coalition and the CCR. The three key people who spear-headed

this drive to have a public inquiry (Carson Chisholm, Perry and Helen Dunlop) were involved in the entire process starting in 1993 until the public inquiry got started, and the key people in The Coalition For Action worked with these 3 key prime movers.

The CCR were never involved until after the petitioning began to have the public inquiry. The history of the grass roots movement among the citizens of the Cornwall area always involved these three movers (until Perry and Helen Dunlop moved to British Columbia) who worked in conjunction with the core people in the Coalition.

This public inquiry must not be misled into thinking that the CCR are somehow the voice of the people who agitated for a public inquiry. These 3 prime movers never worked with the CCR.

Therefore the true history of how the citizens of Cornwall agitated and petitioned for a public inquiry can only be told if Carson Chisholm and The Coalition get standing and funding to participate in the process.

The mandate for The Coalition can simply be summarized as "They being the true representative voice of the people who desired to have a full and truthful public inquiry into the detestable child sexual abuse scandal in Cornwall". They were the workers who canvassed door-to-door, in shopping malls, in parking lots, and other public institutions gathering names in support of this call for a public inquiry. The Coalition are the people who participated in public meetings, displayed signs at rallies, etc, with Carson Chisholm pushing for this inquiry.

The public would be deceived if this true history was not taken into account at the public inquiry, and the only way this could be done would be if Carson Chisholm and The Coalition got full standing and funding.

HOW IS CARSON CHISHOLM AND THE COALITION DIFFERENT FROM THE OTHER GROUPS THAT ARE PARTICIPATING IN THE INQUIRY?

First of all, Carson Chisholm and The Coalition know the history of this grass roots movement, because they were the grass roots movement. The victims and the supporters of the victims know the truth, that it was Carson Chisholm and The Coalition who got this inquiry started.

They know that if Carson Chisholm and The Coalition are not involved, the taint of "cover-up" will be still on this Inquiry. If Carson Chisholm and his group never compromised in 15 years of advocating for this public inquiry, then they are the only ones who can bring legitimacy to this entire process. If they are not involved, then the reality of this cover up becomes ever more obvious.

The parties to the Inquiry must come face-to-face and look eyeball-to-eyeball on a continuing basis with their conscience and Carson and The Coalition, who made this whole process possible. If they are excluded by the Commission than the public will know that it is guilt that makes it impossible for them to face Carson Chisholm and The Coalition on a day to day basis at the Public Inquiry.

So far it appears that the Public Inquiry want to bring Perry Dunlop, Helen Dunlop, and Carson Chisholm before the Public Inquiry, attack them, and try to discredit them, and sent them home and continue to attack their reputation until this inquiry is over.

By removing Carson Chisholm and The Coalition you are in effect removing the voice of righteous indignation of the people in the Cornwall area.

Because of the involvement of Carson Chisholm and The Coalition there are groups that want to come forward and state their position before the commission. Carson Chisholm and The Coalition are trusted because they never gave up.

The uncompromising stance of The Coalition and Carson Chisholm against unbelievable opposition makes it mandatory that they get standing and funding to participate in the process. If they do not get standing and funding then all you will get is hand picked participants who are going to advocate the party line.

THE ROLE OF CARSON CHISHOLM AND THE COALITION IN THE INQUIRY

Carson Chisholm has an intimate knowledge of the history involved in how this public inquiry came about. He has personal knowledge of a lot of what has transpired and he knows the parties. He first of all, wants to make sure that the people who come before the inquiry, of whom he has personal knowledge of, tell the truth. He is a reservoir of information that cannot be garnered from looking at the documents. He was there.

The Inquiry should not be used as a platform to disseminate distortions of fact. The best way to stop this is to have someone like Carson Chisholm to be there at the inquiry to help prevent it from happening.

The Coalition has a role to play because they were like the hands and feet of Carson Chisholm in gathering names, signatures, and trekking off to Toronto to Queen's Park to let the voice of the people of Cornwall to be heard.

The moral voice of the people of Cornwall was spoken through Carson Chisholm and The Coalition. The detestable acts done by these sex abusers gave rise to a feeling of repugnancy in the people of Cornwall.

The applicants gave voice to this feeling in the hearts of the people, and it was

this uncompromising attitude of contempt for these detestable acts that gave rise to this public inquiry.

If you remove the voice of the people, then the impetus to have the inquiry is no longer there. It becomes either a cover up or some bland unimpassioned intellectual discussion about a subject which is morally and spiritually wrong. Carson Chisholm, a devout Christian, knew that this was wrong because God says it is wrong, and it is damaging and destructive to society.






